Keynote Address By Beth Mount

Revolutionary Mentoring: Being The Change We Want To See In The World...

This keynote creates space for us to honor, celebrate, and make visible the countless ways that direct support professionals and their partners are making a difference in the lives of people and communities, and consequently building a better world for us all.

Workshop Session A

Community Participation Services— From Regulations to Implementation

Presenters: Peter Bacon, Community Residence Coordinator, Bureau of Developmental Services (BDS) & Rocky Morelli, Executive Director, Opportunity Networks

Have you ever wondered what is allowed and not allowed for day programs? Do you know what the term "Medicaid Billable" refers to?

This workshop will give you the opportunity to learn about the changes in the He-M 507 Community Participation Services regulation from the perspective of both certification and DSP Implementation. You will learn about weekly schedules and billing, 80%–20% requirement and the role the service agreement plays in day services. Ultimately how to provide "A Meaningful Life" to the individuals you support.

Workshop Session B

Center for Medicare and Medicaid Services Rule Setting Changes—Knowledge Is Power

Presenter: Mary St. Jacques, HCBS Project Manager, Institute on Disability/ UCED, University of New Hampshire

Mary has spent over 30 years in the Developmental Services field, focusing on advocacy, quality improvement and training. Her work experience includes serving as a Direct Support Professional in both day and residential settings, respite provider, and enhanced family care provider. Currently, Mary is coordinating the statewide effort to meet the expectations for home and community based settings that the Centers for Medicare and Medicaid (CMS) have developed.

This workshop will:

- Explain the new CMS expectations
- Identify how the expectations impact individuals receiving services
- Share the goals being worked on to achieve compliance
- Give a status update on the progress of the goals

Creating Stories That Celebrate Valued Lives

Looking Back, Moving Forward, From Institutionalization to Self Determination—The Long Journey

William K. Schofield PhD. received his doctorate in Education from the University of Illinois, at Champaign/Urbana in 1981. He moved to New Hampshire where the closure of Laconia State School had been ordered by the court in Garrity vs. Gallen. After teaching at Fitchburg State College in Massachusetts, Dr. Schofield was hired by the State of New Hampshire to create a training curriculum that addressed the myriad of issues surrounding the deinstitutionalization of the 700 people that were then leaving the institution and being assimilated into the community. In 1985 Dr. Schofield established Residential Resources Inc. to respond to a growing need for appropriate support for people with a variety of life altering circumstances. Dr. Schofield has been an active advocate for people and their support teams and believes it is the commitment and dedication of direct support professionals that change lives and bring meaning and fulfillment to the lives of the people they support.
